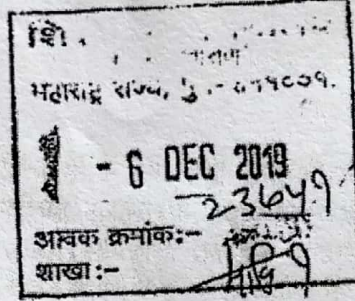

महोदय,

हैद्राबाद मधील तरुणीवर तसेच मागील काही महिन्यापासून सातत्याने विद्यार्थी - तरुणीवर होत असलेल्या विनयभंग तसेच नुकतेच हैद्राबाद मधील तरुणीवर झालेल्या अमानुष अत्याचार व हत्येचा समाजाच्या सर्व स्तरातून निषेध निदर्शने झालेली आहेत. अशी घटना घडल्यानंतर सर्वत्र निषेध निदर्शने होत असताना शिक्षण विभागाला मात्र अशा विषयाचे गांभीर्य दिसत नाही.

याचे प्रामुख्याने कारण म्हणजे सर्वोच्च न्यायालयाने स्त्रियांच्या कामाच्या ठिकाणी होणाऱ्या लैंगिक छळाच्या अनुषंगाने घालून दिलेली मार्गदर्शक तत्त्वे आहेत त्यानुसार महाराष्ट्र शासनाच्या महिला व बालविकास विभागाने एक शासन निर्णय पारित केला होता. त्यामध्ये शासकीय, निमशासकीय सेवेतील महिला कर्मचाऱ्यांच्या लैंगिक छळाच्या समस्यांची तपासणी करण्यासाठी शासनाने नियुक्त केलेल्या समितीच्या शिफारशीची अंमलबजावणी आणि त्या अनुषंगाने सर्व कार्यालय, संस्थात समित्या स्थापन करण्याचा महिला समितीच्या संदर्भातील सर्वसमावेशक आदेश पारित करण्यात आला होता. वरील आदेशाच्या परिपत्रकाद्वारे शासकीय, निमशासकीय, शाळा, महाविद्यालय असे कार्यरत असलेल्या महिला कर्मचारी, विद्यार्थीनी यांच्यावर लैंगिक अत्याचाराच्या घटनांचा प्रतिबंध बसवण्यासाठी महिला तक्रार निवारण समितीची शालेय विशाखा समितीची रचना करण्यात यावी असे नमूद करण्यात आले होते. शालेय आवारात कार्यालयामध्ये होणाऱ्या महिलांच्या लैंगिक छळावर प्रतिबंध घालणे, महिला कर्मचारी, विद्यार्थीनी यांच्या समस्या सोडविणे या उद्देशाने या समितीची स्थापना करण्याचे आदेश दिलेले होते.

यातच सुधारणा होत अठरा वर्षाखाली विद्यार्थीनींच्या समस्या सोडविणे पोकसो (POCSO) व अठरा वर्षाच्या पुढील विद्यार्थी संरक्षण समस्या सोडविणेसाठी पॉश (POSH) या समितीची स्थापना करून जनजागृती तसेच स्वरक्षणाचे धडे देण्याचे सुचविले होते.

परंतु शालेय शिक्षण विभाग तसेच उच्च शिक्षण विभागाला या विषयांचा विसर पडलेला दिसत आहे. बहुतांश शाळा, महाविद्यालय, विद्यापीठामध्ये विद्यार्थीनी, महिला कर्मचारी यांच्या समस्या सोडविणे साठी या समितीची स्थापनाच आजपर्यंत झालेली दिसत नाही.
